Small Industries Development Bank of India (SIDBI) (<https://www.sidbi.in/enis>) is the implementing agency of MoHUA for this scheme. SIDBI has set up a Project Management Unit (PMU) to provide focused support for the implementation of PM SVANidhi Scheme. The objective is to manage, coordinate, and monitor the PM SVANidhi by providing programmatic support to the MoHUA/SIDBI efficiently and effectively. The PMU would operate under the over supervision of MoHUA and SIDBI.
